#### 4.2 Most important symptoms and effects, both acute and delayed

### 5.2 Special hazards arising from the substance or mixture

#### Large spill

: Stop leak if without risk. Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. ### 8.2 Exposure controls
